With reference to the above, a representative of the office visited your Educational Building to the above-mentioned address for inspection of firefighting arrangements provided to the constructed building since the firefighting arrangements provided were found in satisfactory working conditions, this office is issuing "Final Approval of compliance from fire safety point of view to occupy and use the Educational building" having built up area admeasuring to 5552.23sq. mtrs.

The said company has kept marginal free space from the obstruction as per NBC part IV and the firefighting system is installed by the Licensed Agency M/s Vision Fire & Safety Engineering (MFS-LA/2019/RF-141, MFS-LA/2019/RD-132) and he was submitted certificate in "Form A" prescribed in Maharashtra Fire Prevention & Life Safety Measure Rules 2009.

The said company has provided Extinguishers, Hose Reels, Fire Alarm System and Pump (01 No. Electrical driven Stand by Pump- 1620 lpm, 01 No. Electrical driven Main pump - 1620 lpm, 01 No. Electrical driven Sprinkler Pump - 1620 lpm & 01 No. Jockey pump 180 lpm). Now the said company has requested to issue "Final No Objection Certificate" for your building.

Statutory Provisions Under Maharashtra Fire Prevention and Life Safety Measures Act, 2006.

1. Under Section 3of "Maharashtra Fire Prevention and Life Safety Measures Act, 2006." (hereinafter refer to as "said Act"). The applicant (developer, owner, occupier by whatever name called) shall comply with all the Fire & Life Safety measures adhering to National Building

Code of India, 2006 and as amended from time to time failing which it shall be treated as a violation of the said Act

2. It is presumed that you have certified the work adhering to the provisions under **Section 3** of the said Act.
3. **Sub-section (3) of section 3**, it is responsibility of the Owner or the Occupier as the case maybe, shall furnish to the Chief Fire Officer or Nominated Officer a certificate in a prescribed form twice a year in the month of January & July regarding maintenance of fire prevention and life safety measure in good repair and efficient condition as specified in **sub section (1)**
4. Under **sub section (4) of Section 3**. No person shall tamper with alter, remove or cause any injury of damage to any fire prevention and life safety equipment installed in any such building or part thereof or instigate any other person to so.

The premises under construction was inspected by Shri. Prakash Shankar Borade, Mira Bhaindar, Municipal Corporation on 06.10.2020 & report was submitted on 13.10.2020. **The Fire Fighting System provided by you in the building premises as per provisional No-Objection Certificate shall be maintained & shall be kept in good working condition at all the time. If the fire protection system is not maintained, retrenched then this "N.O.C." will stand cancelled without notice & you will be solely responsible loss of life or property if any which may please be noted.**

The condition mentioned in the "Provisional No-Objection Certificate" will remain unchanged. The undersigned reserves right to amend any additional recommendations deemed fit during the stage wise inspection due to the statutory provision amended from time to time and in the interest of the protection of the company. **If any change of Activity or Transfer of Plot or any further expansion, No Objection Certificate from this office is essential.**

As per Maharashtra Fire Prevention and Life Safety Measures Act, 2006, Section 25-Annexure- Part III, Mr. Vinod Dattatray Adhikari, has paid Fire Protection Fund Fees of Rs 44,450/- (Rs. Forty-Four Thousand Four Hundred Fifty only) vide UTR No. BKIDN19017697888 as per certified by the then Architect vide his letter.

However, Town Planning is requested to verify the total built up area and inform this Department for the purpose of levying addition Capitation Fee
